### **Course Description**

This class explores the literary, religious, theological, historical, and social worlds of The Acts of the Apostles. It also attends to the reception of Acts throughout history and how the book is presently read in various social contexts. In the class, students will practice and develop various exegetical skillsets related to the interpretation of the New Testament and Acts specifically. In the act of interpretation, they will merge their own intersectional social worlds with that of Acts.

#### **Course Format and Location**

This course topic is taught simultaneously in two formats: as a for-credit graduate course (3 credits) and as a non-credit enrichment course. These two courses have overlapped instruction time and a shared course Moodle page but different coursework expectations. All students are expected to attend all in-person sessions. Students taking the for-credit course are required to do more reading and writing. For-credit students will receive a letter grade while enrichment students will be graded pass/fail for the course.

Both enrichment and for-credit students will engage with both online (Canvas) and in-person course elements. Canvas is where you will find the syllabus, weekly video lectures, and links for uploading your assignments. Lectures will be posted every Thursday to be watched before Tuesday's class.

This class meets in person at (TBD church, Madison, WI) on Tuesdays (6:00-7:40 pm) from 9/9/2025 through 12/8/2025 with a Saturday morning retreat in September. No class will be held on two dates, TBD. Optional community dinners are available at 5:30 pm.

## **Course Learning Outcomes**

Students who successfully complete this course will be able to:

- 1. Exegete a select passage from Acts, paying attention to the world behind, world of, and world in front of the text.
- 2. Identify and articulate central tenets of your own social context, explaining how these affect how you interpret the New Testament and Acts in particular.
- 3. As part of the interpretive process, make use of multiple biblical commentaries that adopt various exegetical, theological, and ideological perspectives.
- 4. Utilize tools in service of interpretation of Acts and select passages from it.

- Interpret the Christian Scriptures through faithful exegesis and in light of the Christian tradition (MDiv)
- Preach the Word of God with faithfulness and clarity (MDiv)
- Be formed by, live in, and minister out of Scripture and the historical and theological tradition of the church (MDiv)

- Identify and interpret key themes from the Christian scriptures (MAM)
